ARTICLE 2
AREAS OF COLLABORATION

The areas of collaboration will focus on:

2.1. Education and Training: TMDA will assist in the training of CUHAS students by providing technical expertise, training materials, and facilitating practical sessions.

2.2. Research Activities: CUHAS and TMDA will collaborate in research activities whereby TMDA will provide laboratory facilities, technical personnel and a contact person to facilitate CUHAS research projects.

ARTICLE 3
RESPONSIBILITIES OF THE PARTIES

Each party will participate actively and on a timely basis, providing resources, information and support as necessary and as agreed upon in specific project agreements after this MoU.

ARTICLE 4
FINANCIAL OBLIGATIONS

- 4.1. The financial arrangements to cover expenses for the cooperative activities carried out within the framework of this MoU should be mutually agreed upon by parties on a case-by-case basis and subject to the availability of funds and resources and in accordance with applicable laws and regulations;
- 4.2. Except otherwise agreed, each Party shall bear its own expenses related to the activities conducted under this MoU.



ARTICLE 5
TERM AND TERMINATION

This MoU will commence on the date it is signed by both parties and will continue for a term of five (5) years, unless earlier terminated by mutual agreement of the parties.

ARTICLE 6
CONFIDENTIALITY

6.1 The Parties agree that they may not disclose, in whole or in part, information classified as reserved or confidential, derived from collaborative activities under the terms of this Memorandum of Understanding, without the prior written consent of the other Party;

6.2 The obligation to protect confidential information, documentation and data obtained under this Memorandum of Understanding remains even if the Parties cease to be bound by the Memorandum of Understanding.

ARTICLE 7
MODIFICATION

This MoU may be modified or amended by mutual consent of the parties, formalized through written communications specifying the date on which such amendments will enter into force.

ARTICLE 8
DISPUTE RESOLUTION

Any dispute arising from this MoU shall be resolved through amicable discussions between the parties. If such resolution is not possible, the dispute shall be resolved by a method upon which both parties agree without any reference to the third party.

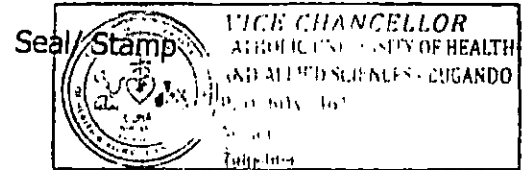

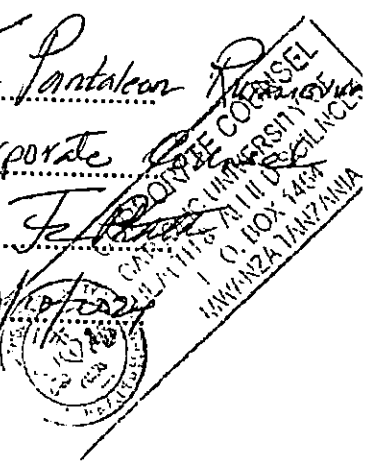

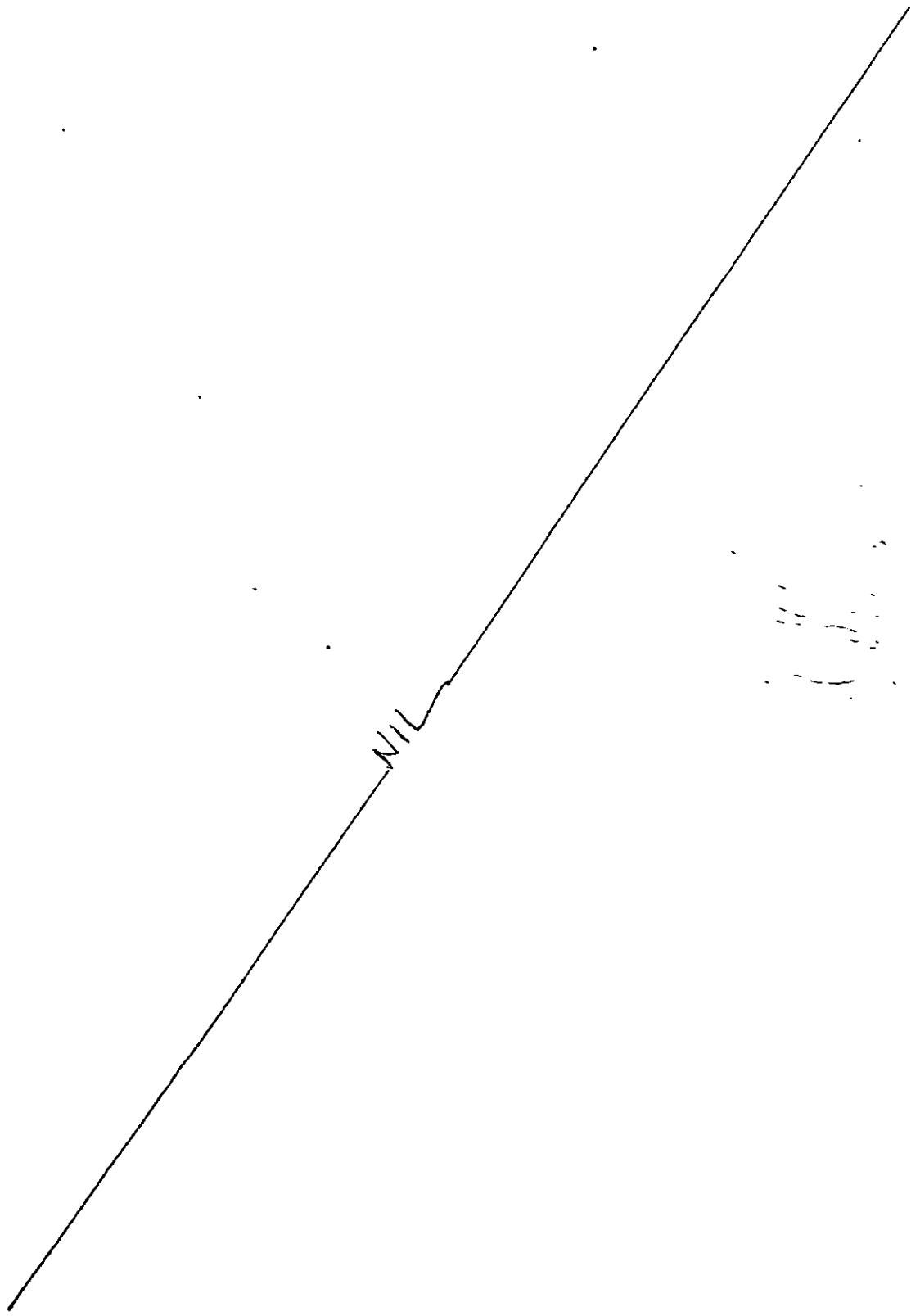
